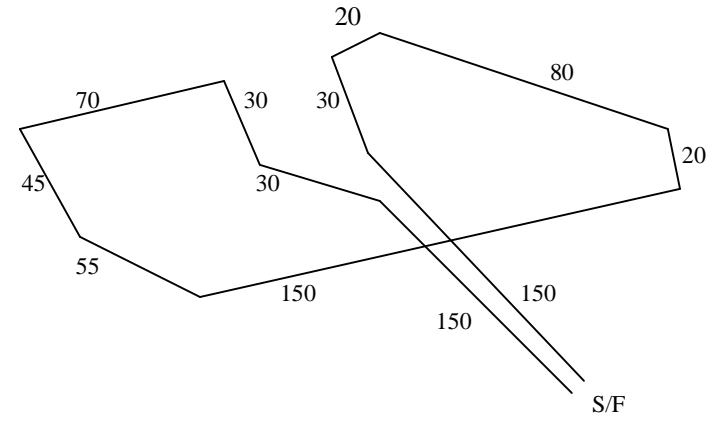

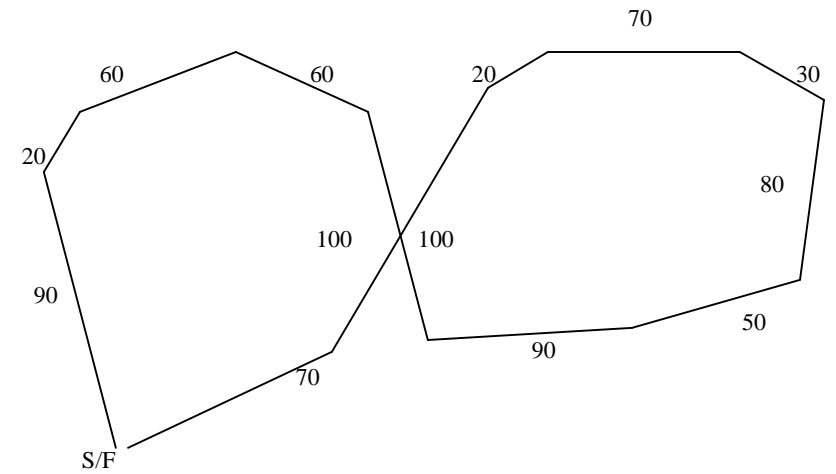

ELIGIBLE BREEDS & REGISTRY

Afghan Hounds, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Italian Greyhounds, Irish Wolfhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds and Whippets. All entries shall be individually registered with the AKC or have been granted an ILP by the AKC.

Effective January 1, 2008: Azawakhs, Portuguese Podengo, Thai Ridgeback and Sloughis, 1 year of age or older, that have been recorded with the Foundation Stock Service (FSS), or that have been granted an Indefinite Listing Privilege (ILP) are eligible to enter lure coursing tests and trial for junior, senior and master courser titles but are not eligible for championship points and are not eligible to run in Best in Field.

Hounds may not be entered as “registration pending” or ILP pending”. Breed disqualifications apply. Hounds that are disqualified (or dismissed twice within six trials) from the AKC, ASFA, or CKC Field Trials may not be entered.

STAKES OFFERED

Junior Courser Test— Hounds must be one year of age or older. Hounds that pass their JC test should be practiced with other hounds before being entered in Open Stake to ensure absence of aggression on the field.

Open Stake— Open to all hounds of an eligible breed that have obtained one or more of the following: AKC Junior Courser title, ASFA Field Champion title, CKC Field Champion title, AKC Field Champion title.

Veteran Stake—Any eligible sighthound that has met certification requirements whose age exceeds six years, except Irish Wolfhounds whose age shall exceed five years.

Special Stake— Open to all hounds that are eligible to enter the Open Stake and have earned their AKC Field Championship title. No championship points are awarded from this stake. Hounds that are disqualified from AKC, ASFA or CKC Field Trials may not be entered.

BEST IN FIELD WILL BE OFFERED.

All hounds will run twice, in twos if possible or braces unless excused, dismissed or disqualified. Bitches in Season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched after a five-minute (5) grace period. Each entry will be examined at inspection for breed disqualifications. Spayed or neutered hounds without breed disqualifications may be entered. Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips. Backup equipment will be available. The course will be reversed for finals, runoff, Best of Breed and Best in Field. Italian Greyhounds are not eligible to run for Best in Field.

RULES & INFORMATION

All hounds will be checked for breed disqualifications.

All entries must be one year of age or over on the day of the trial.

Only in season or lame dogs at time of inspection pre-entries will be refunded.

Bitches in season will not be allowed to run.

Hounds with breed disqualifications and lame hounds will be excused.

Hounds not present at Roll Call will be scratched and entry fees will NOT be refunded.

Spayed or neutered hounds may be entered.

Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled.

It is recommended that Junior Courser hounds entering the Open Stakes for the first time have successful practice experience with other hounds before competing

Lure machine is battery powered, continuous loop. Backup equipment is available.

The field is FULLY FENCED.

A fee of \$25.00 will be assessed for any returned checks.

There will be a \$5.00 fine for any loose hound on the field that is not part of the course in progress.

Persons exhibiting conduct detrimental to AKC / LKC / any hound(s) / other person(s) will be asked to leave the trial site.

Fun Runs will be offered after test and trial competition are complete and as time of daylight permits. \$5.00 per dog per run.

DIRECTIONS TO TRIAL SITE—From I-12 East or West—Take Exit 63B onto Hwy 190 toward Covington. Get in right lane after Wendy's on Hwy 190. Turn right on Hwy 21 (between Walgreen's & Rouse's Supermarket) going toward Bogalusa. Travel Approx. 7 miles, turn LEFT on Hwy 1083 NORTH, go 2-1/2 miles, cross a small bridge and turn LEFT on Fauntleroy Road. Next LEFT will be Chat Blanc Ln.—the field is at the end of Chat Blanc Ln.
